We plan to have seven to eight classes of animals in our contest consisting of:

Breeding Goats

There will be 1 to 2 sets of question classes.

- FFA and 4-H will judge classes together, but will be graded and awarded separately.
- **Livestock Judging Teams will consist of 3 or up to 4 members. A team may participate with 3 members if needed. Only the top 3 scores will count toward the team score. Individuals not on a team may still judge as an individual, but will not be eligible for team awards unless they are placed on a team.**
- Coaches and parents are not allowed to make contact with participants during the contest.
- Use of cell phones or talking by the contestants during the contest is strictly forbidden and could lead to disqualification.
- Contestants will be given 15 minutes for questions classes and 12 minutes for non-reason/non-questions classes.
- Animals may not be handled by contestants during the contest.
- After each class the judging cards will be collected and the contest official will give the placing and reasons on each class, except for the reasons/questions class. Any card not turned in when time is called, a score of zero will be given.
- Awards will be given in 4-H to Junior, Intermediate and Senior Teams and FFA Junior and Senior Teams
- FFA and 4-H High Individual Awards are awarded to the 3 individuals with the highest total number of points

Citrus County Fair Livestock Addendum

Owner represents to **Citrus County Fair Authority** (Authority) that no animals that are exhibited or otherwise transported onto the Citrus County Fairgrounds will in any way be suffering from any contagious or infectious disease. In addition, owner shall defend, indemnify, and hold the **Authority**, the applicable Show Committee and each of the respective officials, officers, directors, employees, and agents harmless of and from all losses, damages, claims, expenses, including reasonable attorney's fees at the trial and appellate levels, actions and causes of action arising out of, or in any way connected with, or by reason of this Agreement, the presence of **Owner's** livestock at the **Citrus County Fairgrounds**, and/or use of the **Citrus County Fairgrounds** including, but not limited to any claim for the death of, or injury to any person, or livestock, or damage to, theft of or destruction of any property arising out of any act or omission of **Owner, Owner's** officer, agents, employees, trainers, drivers, riders, handlers, contactors, and livestock. Violation of any federal, State and Local environmental laws, rules, ordinances, and/or regulations, actions for negligence, wrongful death, torts, defects in the real and personal property at the **Citrus County Fairgrounds** and from any alleged liability, cause, litigation or proceedings whatsoever, even if such injury, death or loss of property damage results, in whole or in part, from the negligence of **Authority**, or the applicable Show Committee and their respective officials, officers, directors, employees and agents or otherwise. Neither **Authority** nor such applicable Show Committee shall be liable to **Owner**, or any officer, agent, employee, trainers, drivers, riders, handlers, or other contractors, invitees or guests of **Owner**, for any injury or damage to livestock, person, or property. **Authority**, its officers or agents, assume no liability for any loss or damage to property (including but not limited to livestock) on account of fire, theft, or any other cause including infections or contagious diseases. In addition, **Owner** acknowledges receiving and agrees to abide by the applicable rules and regulations of the **Authority** titled **Citrus County Fair Livestock Rules and Regulations** and **IFAE National Code of Show Ring Ethics**.
