

**2017 CITRUS COUNTY FAIR ASSOCIATION
RULES AND REGULATIONS FOR TRUCK & TRACTOR PULL
EXHIBITORS and VENDORS**

The following rules and regulations are part of the contract to rent space at the Citrus County Fair Association's Truck & Tractor Pull.

1. Payment of 100% of the cost of any concession or exhibit is due and payable no later than Wednesday, January 4, 2017. Returning vendors are given priority when assigning space. Every effort will be given to reserve space requested. Space will be given on an availability basis after Friday, January 6, 2017.
2. **NO REFUNDS.** Refunds may only be given on an emergency basis and only if the space is re-sold prior to the opening day of the event.
3. **Food Vendors** require a Certificate of Liability Insurance for one million dollars listing the Citrus County Fair Association, Inc., as additional insured and must be mailed by your agent or sent with your contract. **COPIES are not acceptable.** This certificate must be received no later than Thursday, January 5, 2017.
4. Exhibitor set up time will be Friday, January 27th from 8 a.m. until 4:00 p.m. All exhibits must be in place no later than 4:00 p.m.
5. Chairs, paper, tools, electrical cords, etc. are not furnished. **SPACE HEATERS ARE NOT ALLOWED.** Exhibitor will keep assigned area clean and leave it as they found it.
6. Proposed give-aways, contests, drawings, or gifts must be submitted to the Fair management in writing, giving complete details, approval or denial will be given prior to opening day of the event.
7. The Fair Association reserves the right to remove or cause to be removed, any article, exhibit, show, concession, or any part thereof which may be deemed objectionable. Loud speakers and amplifiers are not allowed in exhibit space.
8. Soliciting on the grounds is prohibited, this includes political activity. Exhibitors must stay within their booth area. Exhibitor will not post or distribute any advertising (or political) material, including menus, outside assigned area.
9. Concession and/or exhibit is subject to all state, federal, county, and city laws governing taxes, health, safety of persons and/or property. **COOKING OIL AND/OR GREASE MUST BE DISPOSED OF** as directed by the management.
10. The Citrus County Fair Association is not responsible for any damages or thefts to or from any concession or exhibit, or injury to any person while at, in, or around any concession or exhibit.
11. **EXHIBIT MUST BE MANNED** during the event hours. Space rental is for entire 2 days of event. Leaving early may result in forfeiture of space for the following year.
12. 2 - Two day event tickets will be issued to each Exhibitor. Additional tickets may be purchased. There will be **NO replacement** of any tickets lost, stolen, or misplaced. **Tickets can not be left at gates.**
13. Exhibitor in violation of these rules and regulations or any part of this contract may be denied admission or representation to any future event as a concessionaire or exhibitor. Violations may mean immediate eviction of concession and concessionaire or exhibit and exhibitor from the Fairgrounds. **THERE WILL BE NO REFUNDS.**
14. Exhibitor will hold harmless the Citrus County Fair Association from any act of God, or from any accident or mishap directly connected with the operation of this organization.
15. **Alcoholic beverages are prohibited.**
16. **Pets are restricted to campsite.**
17. Food may not be cooked, sold, or distributed by any other, than a food vendor with our contract.
18. **VERBAL AGREEMENTS CONTRARY TO THIS CONTRACT WILL NOT BE RECOGNIZED.**
